

ROCKY FORD CITY COUNCIL

April 9, 2019

Rocky Ford City Council met in Council Chambers for a work session at 6:00 p.m. on Tuesday, April 9, 2019. Items on the work session agenda were discussion of putting additional 1% sales tax question on November 2019 election ballot and updates by Police Chief Angelo Griego and Public Works/Water Director Rick Long. Others in attendance were City Clerk Cheryl Grasmick, Dexter Buck, Thomas Martin, James Massengill, Peggy Sue Romero, Gerri Clark, Jolly Rose, Daryl Grasmick and Laura Thompson.

ANNOUNCE CANDIDATES FOR WARD II COUNCIL VACANCY

Mayor Thompson announced that the three residents who submitted letters of interest for the vacant Council Ward II seat were Dexter Buck, Thomas Martin and James Massengill. He then called them forward for the interviews. James Massengill, who was present at the Council worksession earlier, was not present for the regular meeting. Dexter Buck and Thomas Martin came forward and sat in front of Council for the interviews. Council took turns asking the candidates a question and then giving them the opportunity to answer.

Council chose to vote on a ballot for their Ward II choice. They marked the name of the person chosen and then signed their name to the paper. The four ballots were given to City Clerk Cheryl Grasmick to tally, who then announced that it was a tie vote, 2-2.

Following a short discussion regarding how to break the tie, Councilmember Jung moved to appoint Dexter Buck to the vacant Ward II Council seat. Motion then died for lack of a second.

It was then moved by Councilmember Ruiz and seconded by Councilmember Hunter to appoint Thomas Martin to the vacant Ward II Council seat. Voting results were:

It was a tie vote, 2-2, so motion did not carry.

TRI-COUNTY FAMILY HOUSING "CRUISIN' INTO SUMMER"

Sarah Dillon, Executive Director of Tri-County Family Care Center, presented her plans for their 14th Annual "Cruisin' Into Summer" event on Saturday, June 1, 2019. Tri-County is partnering with Total Concept for this event. Councilmember Jung moved to approve the Request to Use Public Right-of-Way, which includes closure of designated streets, as presented, and to waive the vendor fees for participating vendors

with the understanding that sales tax would be collected on their sales at the event and submitted to the State for reimbursement to the City. Voting results were:

STAFF REPORTS

In the absence of Interim City Manager Shannon Wallace, City Clerk Cheryl Grasmick gave Council copies of the draft of the Gobin Building Complex Lease that Shannon prepared. Council is supposed to review the draft and make any suggestions or changes they would like to see. Council was also informed that Tracey Martin from Norm Murphy Realty was the only candidate who had shown interest in listing surplus City property for sales. Council can discuss these two issues at the next meeting.

City Attorney Bart Mendenhall will investigate the additional 1% sales tax ballot question for the next election. It was noted that sales tax questions do better in the odd-numbered municipal election years rather that the even-numbered general election years.

MAYOR/CITY COUNCIL REPORTS/UPDATES

Councilmember Jung reported on the March 31st Rocky Ford Swimming Pool Commission meeting. Cindy Abert, pool manager, has life guards lined up and everything ready to go. The commission anticipates keeping pool prices same as last year, with the exception of raising concession prices. Plans are to have the pool up and running for Blue Marlin practices and to open for Jump Start.

Councilmember Hunter reported Tree Board will meet next week. Phyllis Adkins, Tree Board chairman, will be retiring from Tree Board and moving from the area soon. Jerry Sitton is willing to serve as Tree Board chairman when Ms. Adkins leaves. Councilmember Hunter asked that Public Works Director Rick Long be directed to check on watering of new trees that were planted at cemetery. The trees were planted with money from the grant Tree Board received and would need to be replaced at City's expense if they are lost.

Mayor Thompson reported the Arts Commission met Monday. The Grand Theater is still operating in the black, barely. The Friday night crowds at the theater are dwindling.

CITIZEN PARTICIPATION

Peggy Sue Romero asked for results of the Lisa Carter settlement. City Attorney Mendenhall advised her that it is still in negotiation. The lead attorney for the City is from CIRSA.
