November 26, 2019

Work Session:

Mayor J.R. Thompson and Councilmembers Barbara Hunter, Rich Geist, Marty Lee, Cuco Ruiz and Susan Jung met for a Council Work Session at 6:00 p.m. on Tuesday, November 26, 2019. Others present were: City Manager Shannon Wallace, City Attorney Bart Mendenhall, City Clerk Cheryl Grasmick, Public Works Director Rick Long, Finance Director Azucena Estrada, Otero County Public Works Director Lex Nichols, Toni Madrid and Joe Ayala of Edward Jones Investments, Matthew Holland, Peggy Sue Corbin Romero and Jolly Rose. Items on the agenda were a presentation by Toni Madrid and her associate regarding their company's retirement benefit plans for employees, a proposal by Lex Nichols to partner with City for building a dirt bike park on City property at 8th and Pine on the old Lincoln School playground, and information from Public Works Director Rick Long of potential problems with Zone 5 and need for a subsurface leak detector.

CITIZEN PARTICIPATION

Richard White, accompanied by family members, spoke to Council regarding moving the old 1918 fire truck currently housed in the Rocky Ford Museum Carriage House to the lobby of the new Public Safety Building. He suggested it was more appropriate to display it there. Jolly Rose, local resident, commented that moving the 1918 fire truck from the museum carriage house to the new public safety building would allow

more people to view the artifact. Councilmember Geist also agreed with Mr. White and Ms. Rose. Mr. White was advised that this matter would be more appropriately addressed by the new Council.

STAFF REPORTS/UPDATES

Move 1918 Fire Truck From Rocky Ford Museum To New Public Safety Building

City Manager Shannon Wallace asked Council to consider the proposal of moving the old fire truck to the Public Safety Building. Council discussed the suggestion made by Richard White during Citizen Participation. Councilmember Geist was asked if the old fire truck still ran and he replied no. Following discussion, it was moved by Councilmember Ruiz and seconded by Councilmember Holland to move the 1918 fire truck from the Museum Carriage House to the new Public Safety Building. Voting results were:

Scott White commended his father, Richard White, for the work he had done in raising funds and helping to get the new Public Safety Building built. He offered to cover the cost for moving the 1918 fire truck from Rocky Ford Museum to new Public Safety Building and asked the City to send him the bill.

Proposal to Sell Old Public Works Garage by Fairgrounds

City Manager Wallace asked Council for their thoughts on selling the old public works shop by the fairgrounds. There are at least two community members who have expressed interest in acquiring this property to expand their current businesses. Following discussion, Councilmember Ruiz made a motion to move forward with exploring the sale of the old public works garage at the fairgrounds as proposed by City Manager Wallace. Councilmember Geist seconded motion. Voting results were:

Condemned Garage Adjoining J.C. Carrica property at 966 & 968 Front Street:

City Manager Shannon Wallace recommended that Council consider deeding over the condemned garage attached by a common wall to the property at 966 and 968 Front Street (the former Smiths' Tavern also known as Aragon's Tavern), recently acquired by J.C. Carrica of the Southeast Health Center. The small garage was part of the McClain property that City recently purchased for new public safety building. City was unaware they owned this small garage. The EPA did not consider it enough of an emergency to take care of and took it off the list of potential addresses to demolish with their help. Following discussion, it was the general consensus of Council to move forward with this. They instructed City Attorney Bart Mendenhall to draft paperwork to deed the garage to Mr. Carrica and his group.

Consideration of Waiver For Benefit Health Advisor Mark Hilliar:

City Manager Wallace recommended that Council consider allowing her to sign a waiver to allow Benefit Health Advisor Mark Hilliar to access employee records to assist in finding better, more affordable healthcare coverage for city employees. She told Council that when the Town of Swink brought them on board, they saved the town \$17,000 annually. A benefit analysis would have to be performed before it could be determined if savings could be realized for the City of Rocky Ford. Following discussion, it was moved by Councilmember Geist and seconded by Councilmember Holland to sign the waiver so that a health benefit analysis could be performed by Health Benefit Advisor for the City. Voting results were:
