

#### ROCKY FORD CITY COUNCIL

February 26, 2019

Rocky Ford City Council met in Council Chambers for a work session at 6:00 p.m. on Tuesday, February 26, 2019, with Interim City Manager Shannon Wallace. Others present were Rick Long, Erik Encinias, Jolly Rose, Christian Burney, Peggy Sue Corbin Romero, Cheryl Grasmick, Laura Thompson and the new dispatch employees. Public Works Director Rick Long introduced Erik Encinias, Public Works Foreman. June Ferraro, the new Dispatch Supervisor, introduced new Dispatch employees Camea Baggs, Heidi Eddy, Erica Stetler and Patrick Arrona. Interim City Manager Shannon Wallace introduced Azucena Estrada, new Finance Director. Public Works Director Long gave an update on water issues and sewer lagoons. Interim City Manager Wallace advised Council that the Arkansas Valley Fair & Exposition Board would like to add grandstands over by the announcer's booth on fairgrounds.

### STAFF REPORTS

#### Letter to H.E. Whitlock

Interim City Manager Shannon Wallace presented a letter addressed to H.E. Whitlock that was requested by their bonding company. This letter confirms that funds were available to finish phase I of the new public safety building. Mayor Thompson read the letter out loud for the record. It was moved by Councilmember Jung and seconded by Councilmember Lee to authorize the Mayor to sign the letter to H.E. Whitlock confirming financing for the public safety building, as presented. ## Fire Hydrants Repair

Interim City Manager Wallace presented a bid from Wayne Walter Excavating for repair of three fire hydrants. Councilmember Lee moved to approve the contract with Wayne Walter Excavating for repair of three fire hydrants for the total cost of \$3,300.00, as presented, and to authorize the Mayor to sign contract. ## RF RURAL FIRE PROTECTION DISTRICT - APPROVAL OF IGA

Councilmember Ruiz moved to not move forward with the IGA between the City of Rocky Ford and the Rocky Ford Rural Fire Protection District at this time. The motion died for a lack of a second.

Interim City Manager Wallace and Councilmember Lee represented the City in negotiations with the RF Rural Fire Board to prepare the proposed agreement. Councilmember Lee listed the following amendments and correction to the agreement draft presented to Council earlier:

- 1. Change "Memorandum of Agreement" to "Intergovernmental Agreement".
- 2. Strike set number of volunteers listed on page 2, item 2 of terms. This was eliminated because it is not known how many volunteers will actually respond to each call.
- 3. Add the word "agents" to item 3 wording "all maintenance of District equipment shall be performed by certified personnel and 'agents' ".
- 4. Add the word "area" to wording in item 4 for where dispatch services will be provided.
- 5. Fix typo in the 'Whereas' section.

Following discussion, Councilmember Patrick moved to approve the Intergovernmental Agreement between the City of Rocky Ford and the Rocky Ford Rural Fire Protections District as presented, with the noted amendments and typo correction, and to authorize the Mayor to sign the agreement. Motion was seconded by Councilmember Jung. Voting results were:

Councilmember Jung gave an update on the recent CML meeting she attended in Denver. She asked Council if she could be reimbursed \$110.00 for the registration fee she paid to attend the CML meeting. Then Councilmember Jung reminded Council that First Responders would be recognized at the March 12 Council meeting.

Councilmember Ruiz reported the Library Board will hold special meeting to discuss transfer of some of their building funds to the public safety building fund.

Councilmember Lee attended several meetings for Rocky Ford Rural Fire Protection District and worked on agreement with their board. He will attend Council of Governments meeting February 27. Lee reported that OCLI and OPI both restructured to include the newly elected Otero County commissioner. Landfill closed down site 1 and will overseed when weather is favorable. County road and bridge crews finished bridgework on County Road 21 and will open road by end of week. Highway 71 will be closed between Rocky Ford and Ordway until October while Arkansas River Bridge is replaced. OPI modified loan agreement with Sign Shop.

Councilmember Geist and Museum Board President Daryl Grasmick reported on the recent Museum Board meeting. Museum Board received a grant of between \$5,000-\$6,000 from Burlington Northern Santa Fe Railroad to set up display section dedicated to railroad memorabilia. The display will be located in courtyard between Carnegie Building and Carriage House. Mr. Grasmick thanked City for installing requested lights at Museum. The guest lecture series at museum will resume in April.

Councilmember Hunter reported Tree Board cancelled their meeting but are planning an Arbor Day celebration with details to be announced.

### CITIZEN PARTICIPATION

Tom Martin, local resident, announced that he planned to apply for open seat in Ward II, created when Councilmember Rachel Patrick officially resigns March 12, 2019. He gave a brief biography of his real estate and business experience and also advised Council that purchasing the County road grader would be a wise purchase. He thanked Council for letting him speak.
